The City Council will meet in a Public Meeting to enter a Non-public Session to discuss the following topic:

Personnel hiring, compensation, and evaluation.

Mayor Carrier said he would entertain a motion to enter into Non-Public Session per RSA 91-A:3 II(a): the dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a meeting and (2) requests that the meeting be open, in which case the request shall be granted.

Councilor O'Connor said he would make that motion to enter into non-public session; seconded by Councilor Muffett-Lipinski.

Roll Call Vote: 9/0.

[Non-Public Session]

Mayor Carrier said he would entertain a motion to seal the minutes per RSA 91-A:3 III: by recorded vote of 2/3 of the members present taken in public session, it is determined that divulgence of the information likely would affect adversely the reputation of any person other than a member of the public body itself.

Councilor O'Connor said he would make that motion to seal the minutes; seconded by Deputy Mayor Ciotti.

Roll Call Vote: 8/0. Councilor Muffett-Lipinski was absent.

City Manager Joyal asked the Council to authorize his cost of living adjustment of 1.9% that he did not receive last year as a result of the COVID-19 situation, and the addition of 1.1% cost of living adjustment for this year, totaling a 3% effective this fiscal year.

Councilor O'Connor said he would make that motion; seconded by Councilor Gasses.

Roll Call Vote: 8/0. Councilor Muffett-Lipinski was absent.
