Britt Ulinski Schuman, 136 County Farm Road – In support of the budget being presented to the City. Requests that class size and mental health remain a priority.

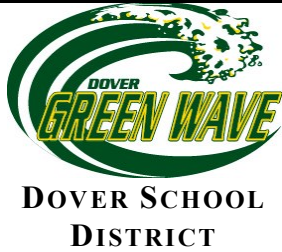
Gretchen Lothrop, 16 Grandview Drive – Thanks the Board for the work being done.
