Shawn Mickelonis – Utilities Commission as an alternate member, Pool Advisory Committee and Recreation Advisory Board as a regular member.

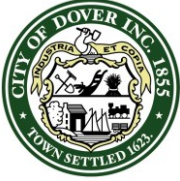
Melissa Wood as a member on the Open Lands Committee.
