**AGREEMENT TO EXTEND HIGH
SCHOOL TUITION AGREEMENT
BETWEEN THE
BARRINGTON SCHOOL DISTRICT AND
THE DOVER SCHOOL DISTRICT**

THIS EXTENSION AGREEMENT is entered into by and between the Barrington School District ("Barrington") located in the county of Strafford and State of New Hampshire, and the Dover School District ("Dover") located in the county of Strafford and State of New Hampshire (collectively "the Parties," or "Parties").

WHEREAS the long-term tuition Agreement between the Parties is scheduled to terminate on June 30, 2024; and

WHEREAS both Parties are amenable to a one (1) year extension of the current Agreement;

NOW, THEREFORE the Parties agree as follows:

1. Extension of Term. The term of the current long-term tuition Agreement (July 1, 2014 to June 30, 2024) between the Parties, which is set to expire on June 30, 2024 is hereby amended and extended one (1) year, commencing on July 1, 2024 and expiring on June 30, 2025.
2. Terms and Conditions. All terms and conditions of the current long-term tuition Agreement shall apply to the extension of this Agreement and shall remain in full force and effect. All post-agreement obligations of both Parties shall continue after the new expiration date in accord with the terms of the extended Agreement unless superseded by a new tuition agreement.
