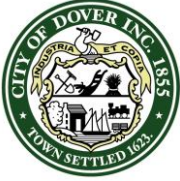

The Committee interviewed Alice Wade for a position on the Racial Equity and Inclusion Committee.

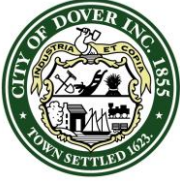

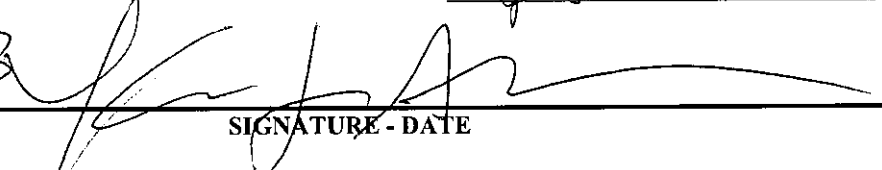
