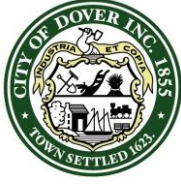

The City of Dover Ordains:

1. **PURPOSE**

The purpose of this ordinance is to repeal the Dover Arena Commission and merge same into the Recreation Advisory Board.

2. **AMENDMENT**

Chapter 9 entitled “Boards, Commissions and Committees”, and specifically Section 9-6, “Dover Arena Commission”, is hereby repealed as follows:

a. **THE FOLLOWING ARE REPEALED:**

**~~§ 9-6. Dover Arena Commission.~~ (Reserved)**

~~A. Membership. The Dover Arena Commission shall consist of five members and two alternate members, appointed by the City Council.~~

~~A. Terms of members. Members shall be appointed to terms of three years.~~

~~A. Authority and duties. The Dover Arena Commission shall serve in an advisory capacity to the City Council and City Manager or designee regarding the operations and maintenance of the Dover Ice Arena. The Commission shall review and develop recommendations for the arena facility and programs. The Dover Arena Commission shall perform the following functions:~~

~~(1) Study, consider and recommend to the City Council and the City Manager, or designee, general policies for the operation of the Dover Arena.~~

~~— Make recommendations to the City Council and City Manager for the ongoing maintenance and operations of the arena, its related programs, capital improvements, budget and fee schedule.~~

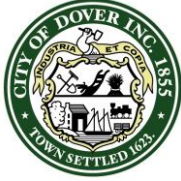
3. **AMENDMENT**

Chapter 9 entitled “Boards, Commissions and Committees”, and specifically Section 9-6, “Dover Arena Commission”, is hereby repealed as follows:

a. **THE FOLLOWING ARE AMENDED:**

**§ 9-5. Recreation Advisory Board.**

A. Membership. The Recreation Advisory Board shall consist of ~~eleven~~thirteen members and three alternates, appointed by the City Council. There may also be a City Council liaison who shall be nominated by the Mayor and appointed by the City Council for the length of

his/her Council term.

- B. Terms of members. Members shall be appointed to terms of three years.
- C. Authority and duties. The Recreation Advisory Board shall perform the following functions:
  - (1) Study, consider and recommend, to the City Council and the City Manager, or designee, general policies for the provision of recreation programs and facilities.
  - (2) Review programs and recommend additions to or deletions of those programs in the City of Dover; advise and recommend to the City Council and the City Manager, or designee, of such improvements.
  - (3) Aid and assist the City Council and the City Manager, or designee, in the formulation of future plans and programs for the ultimate benefit of all users of recreational facilities.
  - (4) Study and recommend methods for financing proposed recreation developments.

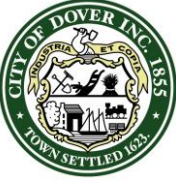
**4. TAKES EFFECT**

This ordinance shall take effect upon passage. The City Clerk shall cause publication of notice as required by RSA 47:18.

**5. TRANSITION PROVISION**

As this ordinance repeals the Dover Arena Commission, the currently appointed and serving members of the Dover Arena Commission are, with passage of this ordinance, hereby re-appointed to the Recreation Advisory Board for (and to the extent of) the remainder of their existing terms for the repealed Dover Arena Commission.
