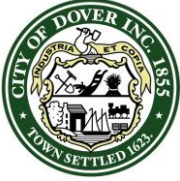

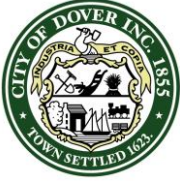
- a. Bobbie Glidden was asking for a waiver we could get when we do have volunteers painting on public property
