NOTE: The non-public meeting is not open to the public per RSA 91-A:3 II(d).

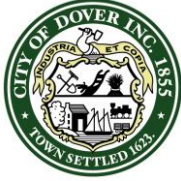
Mayor Shanahan called the meeting to order at 10:06 PM.
