WHEREAS: An insurance adjuster was assigned the claim by the Local Government Center and an appraisal was performed deeming the vehicle a total loss with a value of \$17,045.50. A check was issued to the city for this value less the \$1,000.00 deductible. The city wishes to take advantage of state bid pricing contract for item 2005-38 from Grappone Automotive for a 2008 Ford F350 for the replacement of the 1998 Dodge Ram.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND DOVER CITY COUNCIL THAT:

Per 3-36 B Optional purchasing methods of the Dover Purchasing Ordinance, the purchasing agent with approval of the City Manager may waive the bidding purchase when purchasing through state Bid Pricing.
