


To pass an Ordinance to restrict and or otherwise ban truck traffic on Mast Road between Backriver Road and Route 108, to post such restriction on Mast Road and direct Dover Police Department to enforce the restriction. This restriction shall not allow construction vehicles, dump trucks, heavy haulers of construction equipment, cement trucks etc., but will allow local delivery vehicles, local moving vans, local service vehicles (oil, gas trucks, snowplows etc.), school busses, State, county and City vehicles.

Historically, for many years, this section of road has been used by numerous construction contractors as a "short-cut" to and from numerous construction sites and their unloading/loading site. Traffic has been as high as one truck every five minutes, all day. The road in some places is not wide enough for some of the larger construction vehicles and another car to pass one another. The road surface is collapsing under the constant weight and heavy usage. The area is a highly populated area with children playing, pets, walkers, runners and residents just enjoying their neighborhood; the construction vehicles, many times exceeding the posted speed limit, endangering the lives, safety and property of the surrounding neighborhood and citizens of Dover, NH.
