She discussed the main issues that the Senate will be working on this year. She also discussed the bills that she is sponsoring.

Representative David Watters, District 4, Dover Wards 1 and 2. He serves on the Fish & Game Committee. He discussed the bills that he is sponsoring.

Representative Dorothea Hooper, District 5, Dover Wards 3 and 4. She discussed the new processes she has gone through since she is a new representative. She will be serving on the Municipal and County Government Committee. She discussed bills that they are working on.

Representative Marsha Pelletier, District 5, Dover Wards 3 and 4. She serves on the Legislation Administration Committee.

Representative Donald Andolina, District 6, Dover Wards 5 and 6. He recommended that the Council have a copy of the House of Representative Rules, because it describes some of the things that could happen this year. He serves on the Judiciary Committee.

Representative Peter Schmidt, District 4, Dover Wards 1 and 2. He addressed a few issues with the Council. He said this was the most ideological House of Representatives and Senate he has ever seen, and he felt the agenda being put forth is very radical. He asked citizens to pay attention to the legislation and to voice their opinions in Concord.
