**\*\*Chapter 92 DRIVEWAYS. (01-23-2012 VERSION)** – minor changes outstanding. Footnote for 12-14-1977 Provisions of this Chapter are derived from Ch. 41 of the former code adopted 12-14-1977. Page P92-2 92-3 Section 92-7 clarify with title Paving Contractor’s License, 92-5.A. 2<sup>nd</sup> notation amended -> capitalize, B. change Dover ordinance 92-5A to see section 92-5.A above, page P92-5 92-8 Chapter 152 clarify by adding Streets and Sidewalks, page P92-6 P92-10 “intent and purpose...” -> “intent and purpose of this Chapter 92 Driveways and Chapter 155 Subdivision of Land.

**\*\*Chapter 99 EATING AND DRINKING ESTABLISHMENTS (01-23-2013 version)** minor changes remain in this version. Page P99-4 capitalize in section J.(1) the U in utensils also on P99-5.K.

**\*\*Chapter 100 ELECTIONS (01-23-2013 version)** minor changes remain in this version – some indentation fixes remain. Page 100-4 (2) and (3).

**\*\*Chapter 102 ELECTRICAL STANDARDS (01-23-2013 version)** minor changes and verifications remain in this version. **Need Ordinance for 102-4 when amended (Attorney Krans) – Ordinance number and date.** Would like also Ord. No. 2009.10-14-019.

**\*\*Chapter 109 FIRE PREVENTIN AND LIFE SAFETY (01-23-2013 version)** minor changes remain in this version – formerly, **Attorney Krans will check on standards and fines with Fire Dept.
