The Ordinance Committee worked to finish most of the Dover City Code Codification and Authentication. Chapter's 3 and 5 were the only Chapters not Codified or Authenticated as there is pending Council action on those. The Ordinance Committee's Chapter 1 does not include the Style Guide used for the formatting of the Chapters. The Committee wanted this to be included but there was a lot of pressure to remove it.

Chapter 1 needs a note to signify that Chapter 3 and Chapter 5 were not Codified and Authenticated. Section 1-28 where notes are made for Chapters 166, 170, 92, 149, 155 add D. Chapter 3 and Chapter 5 were repaginated only.
