CITIZEN'S FORUM

STAFF UPDATES

Chris Parker addressed the Parking Commission and updated them on the current status of the First Street Parking Lot, Transportation Center Parking Lot and the School Street Parking Lot. He advised the members that current plans for the First Street Parking Lot are on schedule and that it should go to vote before the City Council on the 24th. Plans for the other two lots are still in the preliminary stages and he will keep the Parking Commission updated as to their status.

OLD BUSINESS

A brief presentation was given by Jeff Taylor and Jack Dugan, two consultants, who are working with the City to put a TIF plan together. They updated the Parking Commission on the current plans to interview people in the downtown area and what to expect in the near future. Tony McManus expressed that the Parking Commission gives their full support on the TIF District.

Chris Parker informed the Parking Commission that a request was made by Tenaru, LLC, to lease 3 overnight parking spaces in the Portland Avenue/Grimes Lot. After a brief discussion, a motion was made by George Maglaras to allow the lease of 3 overnight parking spaces and it was seconded by Jack Buckley. All members present were in favor.
