## DOVER SCHOOL BOARD – MINUTES

A public session of the Superintendent Search Committee was called to order by Committee Chair Betsey Andrews Parker on Tuesday, February 18, 2014, at 6:38 p.m. in Room 305 of the McConnell Center.

Committee members present were Betsey Andrews Parker, Carole Soule McCammon, Beth Dunton, Peter Driscoll, Maybeth Anderson, Melissa Glidden, Ron Cole, Fran Meffen, Robin LaFleur, Bev Shadley, Allan Krans, Linda Smart and Dot Hooper. Rob McGann arrived at 6:40. Also present was Kim Haas, Fosters.

Linda Smart moved, Dot Hooper seconded approval of the meetings from January 23, 2014. An oral **VOTE PASSED 13/0. (Mr. McGann was not present for the vote)**

Ms. Andrews Parker stated that there had been 18 candidates for the position of Superintendent of Dover, but 2 withdrew, making a total of 16 candidates.

Dot Hooper moved, Allan Krans seconded, to enter nonpublic session at 6:41 p.m. to discuss matters that fall under RSA 91-A:3, II (b) The hiring of any person as a public employee, RSA 91-A:3, II (c) Matters which, if discussed would likely affect adversely the reputation of any person, other than a member of the body, RSA 91-A:3, II (j) Consideration of confidential, commercial, or financial information that is exempt from public disclosure under RSA 91-A:5, IV in an adjudicative proceeding pursuant to RSA 541 or 541-A. A roll call vote **PASSED 14/0**. The committee entered non-public session.

Dot Hooper moved, Linda Smart seconded, to adjourn the nonpublic and re-enter the public session at 8:36 p.m. A roll call vote **PASSED 14/0**. The committee re-entered public session. They did not vote to seal the minutes of the non-public session.

The committee discussed its appointment of a subcommittee for developing interview questions. A subcommittee was formed consisting of Betsey Andrews Parker, Carole Soule McCammon, Peter Driscoll, Linda Smart and Bev Shadley.

At 8:45 p.m. Allan Krans moved, Fran Meffen seconded, to adjourn. An oral vote **PASSED 14/0**.
