A public session of the Superintendent Search Committee was called to order by Committee Chair Betsey Andrews Parker on Tuesday, April 15, 2014, at 3:10 p.m. in Room 305 of the McConnell Center.

Committee members present were Betsey Andrews Parker, Beth Dunton, Peter Driscoll, Maybeth Anderson, Melissa Glidden, Ron Cole, Fran Meffen, Robin LaFleur, Allan Krans, Linda Smart, John O'Connor, Bev Shadley and Kim Lyndes. Carole Soule McCammon arrived at 3:15 and Rob McGann arrived at 3:30. Annette Studebaker participated via iPad face time.

Ms. Andrews Parker asked Ms. Studebaker if there was a reason that she was not in attendance. Ms. Studebaker responded that she was out of state. She was also asked by Ms. Andrews Parker if she was alone, to which she responded in the affirmative.

Ms. Andrews Parker explained the process for the interviews and stated that a third applicant had been contact several times without response. She stated that if the search committee agreed to send one or both of the candidates to the School Board, they would perform a more in-depth interview, before proceeding to a public forum. This interview would last for approximately 2 hours.

Linda Smart moved, Melissa Glidden seconded, to enter nonpublic session at 3:15 p.m. to discuss matters that fall under RSA 91-A:3, II (b) The hiring of any person as a public employee, RSA 91-A:3, II (j) Consideration of confidential, commercial, or financial information that is exempt from public disclosure under RSA 91-A:5, IV in an adjudicative proceeding pursuant to RSA 541 or 541-A. A roll call vote **PASSED 15/0**. The committee entered non-public session.

Carole Soule McCammon left the meeting at 4:50 p.m.

Fran Meffen moved, Allan Krans seconded, to adjourn the nonpublic and re-enter the public session at 6:30 p.m. A roll call vote **PASSED 15/0**. The committee re-entered public session. They did not vote to seal the minutes of the non-public session.

The committee discussed what would happen if no candidate is selected by the School Board. Ms. Andrews Parker responded that there would be a meeting scheduled to determine the plan for the next school year.

Allan Krans moved, John O'Connor seconded to approve minutes of this meeting. A roll call vote **PASSED 15/0**.
