Dear Mayor and Members of the Council:

In an effort to keep you informed, we are writing to let you know about a change in our carriage of the NFL Network. Effective July 13, 2007, the NFL Network will no longer be available in Digital Preferred, Variety Pack or Canales Selecto. In order to receive the NFL Network, customers will need to subscribe to our Sports Entertainment Pack (SEP). The SEP includes programming from channels such as CSTV, FCS Atlantic, FCS Central, Fox Movies (FXM), Tennis Channel, FCS Pacific, Fox Soccer, GOL TV, NFL Network, Outdoor Channel, Speed Channel, TVG, BET on Jazz, NBA TV, and Turner Classic Movies. Customers will continue to view NFL Network on its current channel location 265. This programming change does not affect the carriage of NFL games on other networks; all customers will be able to continue to enjoy the full schedule of NFL games carried locally by CBS, FOX, NBC and ESPN.

This change in carriage of the NFL Network is the result of a New York State Supreme Court ruling in early May that allows Comcast to offer customers the NFL Network on a digital sports tier. This decision means that our customers who are NFL fans will be able to watch the NFL Network on our Sports Entertainment Pack, while customers who do not wish to watch these NFL games will not incur additional costs. We believe that this is the best and fairest result for all of our customers.

Notification will be provided to all affected customers beginning June 12, 2007. For informational purposes, we have enclosed a copy of said notice. If you have any questions, please feel free to contact me at 603-224-0957, ext. 202. Please note that the NFL Network has appealed the trial court's decision. If there is any change in the status of this case, we will immediately notify you and our customers.


