DOVER SCHOOL BOARD – MINUTES

Chairperson Amanda Russell called a meeting of the Dover School Board to order on Tuesday, June 28, 2016, at 6:00 p.m. in Room 305 of the McConnell Center.

Those members present were Amanda Russell, Betsey Andrews Parker, Kathy Morrison, Keith Holt, Matthew Lahr, Carolyn Mebert, and Michelle Muffett-Lipinski.

Betsey Andrews Parker moved, Michelle Muffett-Lipinski seconded, to enter nonpublic session at 6:01 p.m. to discuss matters that fall under RSA 91-A:3, II (C) MATTERS WHICH, IF DISCUSSED IN PUBLIC WOULD LIKELY ADVERSELY AFFECT THE REPUTATION OF ANY PERSON, OTHER THAN A MEMBER OF THE PUBLIC BODY ITSELF, UNLESS SUCH PERSON REQUESTS AN OPEN MEETING. THIS EXEMPTION SHALL EXTEND TO ANY APPLICATION FOR ASSISTANCE OR TAX ABATEMENT OF WAIVER OF A FEE, FINE, OR OTHER LEVY, IF BASED ON INABILITY TO PAY OR POVERTY OF THE APPLICANT. This nonpublic meeting is additionally not open to the public per RSA 91-A:3, II (j), CONSIDERATION OF CONFIDENTIAL, COMMERCIAL OR FINANCIAL INFORMATION THAT IS EXEMPT FROM PUBLIC DISCLOSURE UNDER RSA 91-A:5, IV IN AN ADJUDICATIVE PROCEEDING PURSUANT TO RSA 541 OR RSA 541-A. A roll call **VOTE PASSED 7/0. (All in favor)**

The Board entered into non-public session.

The School Board discussed the evaluation of Superintendent Elaine Arbour which was generally positive and favorable.

The School Board will set future evaluation protocol at the July 11th regular School Board meeting and goal setting will be scheduled for a future date.

The Board discussed whether the minutes of the nonpublic session would be sealed and all in attendance determined that they would not be sealed.
