**PROPOSAL FOR THE DRIVER EDUCATION CONTRACT WITH SAU # 61
DOVER HIGH SCHOOL**

I, Stephanie Monza, owner and operator of Tri-City Driving School propose to conduct Driver Education for the students at Dover High School as to the following:

1. Tri-City Driving School will provide the vehicle, instructor, insurance that is in full compliance with State of NH requirements, gasoline, maintenance, repairs, classroom supplies, textbooks, State of NH manuals, and will be solely responsible for such additional operating expenses deemed necessary for each session.

2. As owner and operator of Tri-City Driving School I have, and will continue to maintain State of NH certification as defined in Saf-C 3102.12.

3. As owner and operator of Tri-City Driving School I will continue to ensure that my program is in full compliance with the standards and regulations set forth by State of NH Driver Education Rules. I will be focused solely on the needs of the students as determined by the Dover High School Principal or designee.

4. As owner and operator of Tri-City Driving School I will conduct a minimum of four (4) sessions (fall, winter, spring & summer.) These dates are approximate and contingent upon the approval of the Dover High School principal or designee.

5. The Dover School District will be responsible for providing a classroom.

6. As owner and operator of Tri-City Driving School I will continue to file enrollee and monthly reports with the State as required in a timely manner. I shall manage such duties as related to the driver education program.

7. I will manage Driver Education under the supervision of the Dover High School Principal or designee.

TRI-CITY DRIVING SCHOOL BUSINESS PROFILE

Currently I am entering my 25th year as a driver educator. and have had the pleasure of teaching over 2000 plus students within the Tri-City area. I was employed by SAS Driving School as the sole instructor for five years prior to opening Tri-City Driving School in 2000.

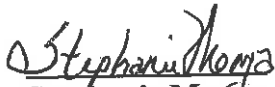
I am proud to say that not once throughout my career have I been asked to come before a School Board or the NH Department of Safety with regard to complaints or concerns from either parents or students.

During my years as an educator I have had open communication with students, parents and teachers so as to provide the most positive outcome for those in my classes. I provide the necessary accommodations for students with any particular learning need, often consulting with special education teachers for the purpose of developing these accommodations.

I make a conscious effort to keep my course fee lower than private driving schools in the area, even though the costs for gas, insurance and maintenance have risen considerably. I provide a safe, well-maintained vehicle; currently a 2018 Mazda 3.

My job can be challenging, but also very rewarding. During the past few years I have taught students whose parents have completed my program in years prior. I am proud to say that they are now entrusting me with their child's driver education. I have a high success rate with regard to the number of my students that pass the State computer and road tests at the Division of Motor Vehicles on the first attempt.

I have developed lasting relationships with some students. My hope is that along with their knowledge of rules of the road I will have instilled in them the enormous responsibility of driving a motor vehicle in a safe fashion , understanding that in an instant the outcome of a careless mistake can not only cost them their life, but that of an innocent person.
